This fund has helped with medical and therapy bills, purchases of durable medical equipment, modifications to homes, wheelchair lifts for vehicles, hand cycles, and much more. The fund is available to families across Kentucky and Southern Indiana. In 2016, the fund assisted 18 recipients with \$14,934.37 in assistance. SBAK seeks donations for all our programs and services. A donor may specify monies directly to the Financial Assistance Fund.
