This fund has helped with medical and therapy bills, purchases of durable medical equipment, modifications to homes, wheelchair lifts for vehicles, hand cycles, and much more. The fund is available to families across Kentucky and Southern Indiana. In 2016, the fund assisted 18 recipients with \$14,934.37 in assistance. SBAK seeks donations for all our programs and services. A donor may specify monies directly to the Financial Assistance Fund.

Children's Programs

Play Pals is one of our most successful programs because families find so much value in meeting with others who are experiencing the same issues, challenges, and success stories. While parents and grandparents talk, the children (including siblings) play in a safe, welcoming, and inclusive environment. The Growing Up with Spina Bifida program addresses the greatest needs and issues our kids face as they grow up with Spina Bifida. While they try to cope, often parents are faced with hard questions from their child and situations they are unfamiliar with. Parents are given the opportunity to learn and discuss these important topics, while the children get to experience hands on learning about their Spina Bifida.
